NOTE 1 - ORGANIZATION AND NATURE OF OPERATIONS

Egeli & Co Tarım Girişim Sermayesi Yatırım Ortaklığı A.Ş. ("the Company") was incorporated and started its financial operations on 19 October 1994. The Company was established under the trade name "Egeli & Co Yatırım Ortaklığı A.Ş." and operated as an investment trust in line with Capital Markets Board ("CMB") legislation but changed its status as an investment trust and turned into a venture capital fund under the trade name "Egeli & Co Tarım Girişim Sermayesi Yatırım Ortaklığı A.Ş." according to its registration on 9 June 2011 at the Istanbul Trade Registry Office. The Company follows the related legislation and CMB regulations in its operating principles, investment policies and management restrictions. The company's shares have been offered to the public and are traded in the Borsa İstanbul A.Ş. ("BİST").

NOTE 2 - BASIS OF PRESENTATION OF THE FINANCIAL STATEMENTS

2.1 Basis of presentation

2.1.1 Financial reporting standards applied and compliance to IAS/TAS

The accompanying interim financial statements are prepared in accordance with the Communiqué Serial II, No: 14.1, "Principles of Financial Reporting in Capital Markets" ("the Communiqué") published in the Official Gazette numbered 28676 on 13 June 2013. According to the article 5 of the Communiqué, interim financial statements are prepared in accordance with Turkish Accounting Standards/Turkish Financial Reporting Standards ("TAS/TFRS") and its addendum and interpretations ("IFRIC") issued by Public Oversight Accounting and Auditing Standards Authority ("POAASA") Turkish Accounting Standards Boards.

The Company's financial statements and notes, as described by the CMB with the announcement dated 7 June 2013 and in accordance with the format by including the mandatory information

In accordance with the CMB's resolution issued on 17 March 2005, companies operating in Turkey which prepare their financial statements in accordance with the CMB Accounting Standards (including the application of TFRS) are not subject to inflation accounting effective from 1 January 2005. The Company's financial statements are prepared in accordance with this decision.

The Company, the accounting records and the statutory financial statements in preparing the CMB issued by the principles and conditions of the Turkish Commercial Code ("TCC"), tax legislation and the Ministry of Finance issued by the Uniform Chart of Accounts complies with the requirements. The financial statements have been prepared on the basis of historical cost, to the legal records for the purpose of fair presentation in accordance with IAS adjustments and reclassifications are reflected.

2.1.2 Offsetting

Financial assets and liabilities are offset and the net amount is reported in the financial statements when there is a legally enforceable right to offset the recognised amounts and there is an intention to settle on a net basis, or realise the asset and settle the liability simultaneously.

2.1.3 Going concern

The Company's financial statements have been prepared using a going concern basis of accounting.

2.1.4 Functional and presentation currency

Items included in the financial statements of the Company are measured using the currency of the primary economic environment in which the entity operates ("the functional currency"), The financial statements are presented in TRY, which is the Company's functional and presentation currency.

2.1.5 Comparatives and restatement of prior periods' financial statements

The financial statements of the Company include comparative financial information to enable the determination of the financial position and performance. Comparative figures are reclassified, where necessary, to conform to changes in presentation in the current period financial statements.

2.2 Significant accounting standards

a) Implementation on Changes in Turkish Accounting Standards and Conceptual Framework

The Company adopted the standards, amendments and interpretations published by the POA and which are mandatory for the accounting periods beginning on or after 1 January 2014.

Standards, changes and comments effective from 31 December 2014 for the annual reporting period:

- TAS 32 (amendment), "Financial instruments: Presentation", on offsetting financial assets and financial liabilities, is effective for annual periods beginning on or after 1 January 2014. The amendment updates the application guidance in TAS/IAS 32, "Financial instruments: Presentation", to clarify some of the requirements for offsetting financial assets and financial liabilities on the balance sheets.
- TAS 36 (amendments), "Impairment of assets" on recoverable amount disclosures is effective for annual periods beginning on or after 1 January 2014. This amendment addresses the disclosure of information about the recoverable amount of impaired assets if that amount is based on fair value less costs of disposal.
- Amendment to TAS 39 "Financial instruments: Recognition and measurement", on novation of derivatives and hedge accounting, effective from annual periods beginning on or after 1 January 2014. These narrow-scope amendments allow hedge accounting to continue in a situation where a derivative, which has been designated as a hedging instrument, is novated to effect clearing with a central counterparty as a result of laws or regulation, if specific conditions are met.
- TFRIC 21 TAS 37, "Levies" is effective for annual periods beginning on or after 1 January 2014. This is an interpretation of TAS 37, "Provisions, contingent liabilities and contingent assets". TAS 37 sets out criteria for the recognition of a liability, one of which is the requirement for the entity to have a present obligation as a result of a past event (known as an obligating event). The interpretation clarifies that the obligating event that gives rise to a liability to pay a levy is the activity described in the relevant legislation that triggers the payment of the levy.
- Amendments to TFRS 10, "Consolidated financial statements", TFRS 12 and TAS 27 for investment entities, effective from annual periods beginning on or after 1 January 2014. These amendments mean that many funds and similar entities will be exempt from consolidating most of their subsidiaries. Instead, they will measure them at fair value through profit or loss. The amendments give an exception to entities that meet an 'investment entity' definition and which display particular characteristics. Changes have also been made TFRS 12 to introduce disclosures that an investment entity needs to make.

The significant accounting policies followed in the preparation of financial statements are summarized below:

2.4.1 Subsidiaries and joint ventures

Joint Venture

Joint venture is a company in respect of which there are contractual arrangements through which an economic activity is undertaken subject to joint control by Egeli & Co Tarım Girişim Sermayesi Yatırım Ortaklığı A.Ş. and one or more other parties. Egeli & Co Tarım Girişim Sermayesi Yatırım Ortaklığı A.Ş. exercises such joint control through the power to exercise voting rights relating to shares in the companies as a result of ownership interest directly and indirectly by itself and/or as a result of written agreements by certain related parties' members and owned by them, whereby Egeli & Co Tarım Girişim Sermayesi Yatırım Ortaklığı A.Ş. exercises control over the voting rights of the shares held by them.

The Company exercises this joint control through the shares they own directly or indirectly and the power to use the voting rights for the shares owned by the related parties on their behalf.

2.4.3 Financial Assets

The Company classifies its financial assets in the following categories: "at fair value through profit or loss", "held until maturity", and "available for sale".

Regular purchases and sales of financial assets are recognised on the "trade date", the date on which the Company commits to purchase or sell the asset.

The classification depends on the purpose for which the financial assets were acquired. Management determines the classification of its financial assets at initial recognition.

Investments are initially recognised at fair value plus transaction costs for all financial assets not carried at fair value through profit or loss.

Financial assets at fair value through profit or loss

The company's fair value through profit/loss reflect this financial investments are classified as financial assets consist of the company's subsidiaries and partners

Financial assets, which are classified as "fair value through profit or loss", are trading financial assets and are either acquired for generating profit from short term fluctuations in the price or dealer's margin, or are the financial assets included in a portfolio in which a pattern of short term profit making exists independently from the acquisition purpose.

Trading financial assets are initially recognised at fair value and are subsequently re-measured at their fair value. The gains and losses formed as a result of the valuation made are booked to the related income/expense accounts. All related realized and unrealized gains and losses, dividends received and interest earned whilst holding trading securities is reported as "Revenues from financial sector".

2.4.4 Sale and repurchase agreements

Securities sold under sale and repurchase agreements ("repos") are retained in the financial statements and the counterparty liability is recorded as due to customers. Securities purchased under agreements to resell ("reverse repos") are recorded as reverse repo receivables on the cash and due from the bank's account, together with the difference between the sale and repurchase price, which is accrued evenly over the life of the agreement using the effective yield method.

2.4.5 Interest income and expenses

Interest income and expenses are recognised in the income statement of the period to which they relate on an accrual basis. Interest income includes coupons earned on fixed income investment securities and amortisation of discounts on government bonds.

2.4.6 Foreign exchange transactions

Transactions denominated in foreign currencies are accounted for at the exchange rates prevailing at the date of the transactions, and monetary assets and liabilities denominated in foreign currencies are translated by using year-end exchange rates of the Central Bank of the Republic of Turkey's bid rates. Gains and losses resulting from the settlement of such transactions and from the translation of monetary assets and liabilities denominated in foreign currencies are recognised in the profit or loss statement.

2.4.7 Property and equipment

Property and equipment are carried at cost less accumulated depreciation. Depreciation is provided on restated amounts of property and equipment using the straight-line method based on the useful lives of such assets (Note 8).

2.4.8 Intangible assets

Intangible assets comprise acquired computer software. They are recorded at acquisition cost and amortised on a straight-line basis over their estimated economic lives for a period ranging from 3 to 5 years from the date of acquisition (Note 9).

2.4.9 Impairment of financial assets

Financial assets except trading financial assets are evaluated each period to determine whether they have indicators of impairment. The financial instruments are accepted as impaired in case that the expected collectable amount calculated by the discounting of expected future cash flows by an effective interest rate or the amount accounted in accordance with the fair value of the instrument are lower than the book value of the instrument.

2.4.10 Revenue recognition

Income and expenses are recognized on an accrual basis. The Company records income from the sales of securities in its portfolio when the sales are conducted.

2.4.11 Fees and commissions

Brokerage commissions are recorded as income or expense at the time the transactions to which they relate are made. All fees and commissions are recognized on an accrual basis and booked under the "Costs from financial sector" account as interest income in the income statement (Note 14).

2.4.12 Taxes

Egeli & Co Tarım Girişim Sermayesi Yatırım Ortaklığı A.Ş. is exempt from corporate tax as per Article 5, sub-paragraph d-3 of the Corporate Tax Law. Moreover, venture capital revenue is not subject to advance tax.

2.4.13 Related parties

For the purpose of the accompanying financial statements, shareholders, key management and board members, in each case together with companies controlled by or affiliated with them, and associated companies, are considered and referred to as related parties (Note 19).

2.4.14 Capital and dividends

Share capital is recognized at the nominal amount and amounts received in excess of the part value are recognized in a share premium account. Incremental costs directly attributable to the issue of new shares or options or to the acquisition of a business are shown in equity as a deduction.

In the event that the shares issued within the scope of capital increases are issued with an amount that is higher than their nominal values, the difference emerging between the issuing amount and the nominal value is recognised under equities as "Share Issuance Premiums".

2.4.15 Cash flow statement

In statement of cash flow, cash flows are classified according to operating, investment and finance activities.

Cash flows from operating activities reflect cash flows generated from petroleum products sales of the Company.

Cash flows from investment activities express cash used in investment activities (direct investments and financial investments) and cash flows generated from investment activities of the Company.

Cash flows relating to finance activities express sources of financial activities and payment schedules of the Company.

2.4.16 Provisions, Contingent Assets and Liabilities

Provisions are recognised when the Company has a present legal or constructive obligation as a result of past events. It is probable that an outflow of resources embodying economic benefits will be required to settle the obligation, and a reliable estimate of the amount of the obligation can and will be made. Possible assets or obligations that arise from past events and whose existence will be confirmed only by the occurrence or non-occurrence of one or more uncertain future events not wholly within the control of the Company and treated as "contingent assets or liabilities" are not included in the financial statements and disclosed in explanatory notes to the financial statements.

2.4.17 Employee benefits

The Company accounts liabilities related to severance pay, vacation rights and other benefits for employees according to the clause "Employee Benefits" ("TAS 19") and classifies them as "Provisions for Employee Benefits" on the balance sheet.

Employment termination benefits, as required by the Turkish Labour Law, are recognized in these financial statements as they are earned. The total provision represents the present value of the future probable obligation of the Company arising from the retirement of its employees regarding the actuarial projections

Provision for employment termination is the discounted amount of the calculated value within the case of retirement of employees of the Company's estimated future liability that will occur within the framework of the Turkish Labour Law (Note 11).

2.4.18 Cash and cash equivalents

Cash and cash equivalents which are immediately convertible to cash and carry an insignificant risk of changes in value, or other short-term highly liquid investments, demand deposit accounts from date of purchase and maturities of 3 months or less than 3 months (Note 3).

2.4.19 Earnings per share

Earnings per share disclosed in these statements of income are determined by dividing the net loss/profit by the weighted average number of shares that have been outstanding during the year.

In Turkey, companies can increase their share capital by making a pro-rata distribution of shares ("bonus shares") to existing shareholders from retained earnings. For the purpose of earnings per share computations, the weighted average number of shares outstanding during the year has been adjusted in respect of bonus shares issued without a corresponding change in resources by giving them a retroactive effect for the year in which they were issued and for each earlier period (Note 18).

2.4.20 Subsequent events

Subsequent events cover any events which arise between the reporting date and the balance sheet date, even if they occurred after any declaration of the net profit for the period or specific financial information was publicly disclosed.

The Company adjusts its financial statements if such subsequent events arise which require an adjustment to the financial statements (Note 22).

2.5 Critical accounting estimates and judgements

Preparation of financial statements requires balance sheet assets and liabilities as of the date reported or described in the relevant period and the amounts of contingent assets and liabilities consists of estimates and assumptions that affect the reported amounts of revenues and expenses. These estimates are based on management's best, current knowledge, and actual results may differ from those estimates. Determination of the fair values of subsidiaries and joint venture carried at fair value in financial statements

Value in use of off-board subsidiaries and joint venture was calculated by discounting the free cash flows by the weighted average capital cost. The value in use calculation is based on the projections confirmed by management and it is sensitive to the growth rate used to calculate the growth and profitability rates, discount rate and estimated cash flow for the post projection period. Discount rate is used (weighted average cost of capital) between the ranges of 12,18% - 13,95% (31 December 2013: 12,62% - 14,06%) for Doğa Tarım, 11.67 % - 12.51% (31 December 2013: 12,62% - 12,99%) for Batı Tarım and 12,51% - 14,69% (31 December 2013: 12,62% - 14,80%) for Tolina Tarım, and 3.0% was used as the constant growth rate for the estimation of cash flows that would occur in the periods after the projection period. Subsidiaries whose shares are not publicly traded and fair values of the joint venture were calculated by discounting free cash flows with weighted average cost of capital. Fair value calculation is based on the projections approved by the management, and growth rates and rates of return for the projection period are sensitive to the growth rate used for calculating the discount rate and estimated cash flows after the projection period. Discount rates used for the calculation were determined considering the current market conditions. They are within the range of 11,03%-12,55% for Doğa Tarım (31 December 2013, 12,62%-14,06%), 9,33%-12,55% for Batı Tarım (31 December 2013, 12,62%-12,99%) and 11,46%-13,23% for Tolina Tarım (31 December 2013, 12,62%-14,80%) on 31 December 2014; a fixed growth rate of 3% was used for fair value calculations of the subsidiaries and joint venture in order to estimate the cash flows that will occur after the projection period (31 December 2013, 3%). The aforementioned valuation study contains estimations on multiple factors, such as future milk, livestock and feed prices, composition of animals in the herd, milk productivity of animals, number of animals in the herd and government promotions and aids other than the discount and fixed growth rate, and is sensitive to the fluctuations in the aforementioned factors.

The most important expense item was feed prices in the projections used to determine the fair value of the subsidiaries and joint venture. Accordingly, the Company management anticipated a rate of increase in the feed prices by 6,50% until 2016, 6% for 2017 and 2018 and 5,50% from 2019 to 2024 in line with the expected inflation increase in the projections approved by the Company management.

The most important income items were milk sales revenues and sales revenues generated from the sale of livestock with low productivity in the projections used to determine the fair value of the subsidiaries and joint venture. The rate of increase in milk prices was anticipated to be 8% by 31 December 2014 in the projections approved by the Company management in line with the historical trend in milk prices (31 December 2013: 5%). In accordance with existing labour law in Turkey, the Company is required to make payments to employees for the remaining vacation days up to the termination date regarding the current salary amount. The unused vacation balance is the undiscounted total liability amount as of the balance sheet date which is equal to the unused vacation balance that has been earned by all personnel.

Provision for employee termination benefits

The provision for employment termination benefits is reserved in line with the explanations below:

Under Turkish Labour Law, the Company is required to pay termination benefits to each employee who has completed one year of service and whose employment is terminated without due cause, is called up for military service, dies or who retires. Since the legislation was changed on 23 May 2002, there are certain transitional provisions relating to the length of service prior to retirement.

The amount payable consists of one month's salary limited to a maximum of TRY3.438,22 (31 December 2013: TRY3.254,44) for each period of service at 31 December 2014.

The liability is not funded, as there is no funding requirement.

The provision has been calculated by estimating the present value of the future probable obligation arising from the retirement of employees. d. Capital risk management

The Company's objectives when managing capital is to decrease the investment risk through portfolio diversification. The Company aims to provide returns for shareholders by preserving and increasing the value of its portfolio. In order to add value to its portfolio, the Company invests in high-yielding marketable securities and other financial instruments, monitors the developments in capital markets and other financial institutions and modifies its portfolio strategy accordingly.

NOTE 21 - FINANCIAL INSTRUMENTS

Fair value of the financial instruments

Fair value is the amount at which a financial instrument could be exchanged in a current transaction between willing parties, other than in a forced sale or liquidation, and is best evidenced by a quoted market price, if one exists.

The estimated fair values of financial instruments have been determined by the Company using available market information and appropriate valuation methodologies. However, judgement is necessarily required to interpret market data to estimate the fair value. Accordingly, the estimates presented here are not necessarily indicative of the amounts the Company could realise in a current market exchange.

The following methods and assumptions were used to estimate the fair value of the financial instruments for which it is practicable to estimate fair value.

a. Financial assets:

Subsidiaries whose shares are not publicly traded and fair values of the joint venture were calculated by discounting free cash flows with weighted average cost of capital. Fair value calculation is based on the projections approved by the management, and growth rates and rates of return for the projection period are sensitive to the growth rate used for calculating the discount rate and estimated cash flows after the projection period. Discount rates used for the calculation were determined considering the current market conditions. The aforementioned valuation study contains estimations on multiple factors, such as future milk, livestock and feed prices, composition of animals in the herd, milk productivity of animals, number of animals in the herd and government promotions and aids other than the discount and fixed growth rate, and is sensitive to the fluctuations in the aforementioned factors.

b. Financial liabilities:

The Company assumes that the carrying values of financial assets and liabilities are close to their fair values are due to their short term maturity.
